# Algae and Mould STOP

## Use

Automatically removes and prevents mould and algae, also indoors, without unpleasant odour emissions. For cleaning building walls, floors, roofs, garages, fences, tiles, clay bricks/blocks, stone, concrete etc. Also suitable as cleaning pretreatment for substrates prior to application of coatings and facade impregnations.

## Constituents

Didecyldimethylammonium chloride, water, additives

## Application

Spray baufan® Algae and Mould STOP onto infected surface from a distance of approx. 15 - 20 cm and allow to work. Acts within 1 - 2 days. In case of very heavy soiling, where no change in appearance of treated surface occurs, perform further treatment with baufan® Algae and Mould STOP. Wash off any residue with fresh water.

## Consumption

50 – 100 ml/m<sup>2</sup>

## Application temperature

+5 °C to + 30 °C for material, ambient air and substrate
