Use

baufan® Universal Paint Stripper is suitable for removing oil paints, synthetic resin coatings and emulsion paints as well as for cleaning rock-hard brushes (excluding plastics bristles).

Constituents

Butyl acetate, dimethyl sulphoxide and thickening agents

Substrate

Universal Paint Stripper does not attack wood, metal or masonry substrates. It may attack plastics and non-solvent-resistant substrates. Free from dichloromethane and N-methyl pyrrolidone.

Application

Mask adjoining surfaces and surfaces not to be stripped with sheet to protect from splashes!

Apply baufan® Universal Paint Stripper generously with brush and allow to work. For difficult-to-strip paint coats, remove softened layer with spatula and repeat procedure. Then wash down surface with water or thinner.

Consumption per coat

Approx. 300 - 600 ml/m²

Application temperature

 $+5~^{\circ}\text{C}$ to + 30 $^{\circ}\text{C}$ for material, ambient air and substrate
