Use:

Solupast D quickly and reliably removes **1. floor covering residue**, e.g. compact foam residue left after stripping out old coverings **2. adhesive residue** from dispersion and synthetic resin adhesives – e.g. floor covering adhesives, residue from adhesive tape and self-adhesive tiles **3. dried paint/coating stains** – e.g. emulsion paints, synthetic resin and acrylic coatings. Ideal for cleaning soiled tools and stiff natural-bristle brushes.

Floor covering and adhesive residue:

Apply Solupast D generously with solvent-resistant brush or roller and, depending on adhesive, allow to work for 15 - 60 minutes. Scrape off dissolved adhesive coat with spatula. Repeat procedure if necessary. Thoroughly wash down surface with water and, where necessary, cleaner and allow to fully dry.

Dried paint/coating stains:

Allow Solupast D to work for approx. 10 - 30 minutes and rub down with cloth to remove stain. Then wash down thoroughly with water.

Cleaning:

Soak stiff natural-bristle brush in Solupast D in glass or metal container. After allowing adequate time to work, rinse out. Smaller metal components shall be placed in and larger metal components wiped over with Solupast D. Then likewise rinse out with water.

Note:

The delayed evaporation of Solupast D allows it to work for long periods without reapplication. Solupast D is a thixotropic gel and can also be applied to vertical surfaces.

Removing agent may attack non-solvent-resistant plastics and mastic asphalt. Prior to use, test surfaces at inconspicuous location for compatibility. Do not use Solupast D on absorbent substrates (e.g. cement screeds). Divide larger areas into sections of max. 0.5 m² for treatment, ensuring adequate ventilation. Allow substrate to fully dry and properly ventilate space before performing subsequent works or installing new floor coverings. Store in cool place in properly sealed containers.

Store in cool, though frost-free environment in properly sealed containers, out of reach of children.
